HEARING PROTECTION



There are multiple areas that require hearing protection at various Dee Zee locations. Your Dee Zee rep providing the escort/tour will inform you when you are entering one of these areas. They are also indicated by signs displaying hearing protection required.

EMERGENCIES



"ALL" Visitors/Vendors are required to be accounted for while on Dee Zee premises. In case of fire, please follow your Dee Zee rep/escort to the nearest designated exit. In the event of Tornado, your Dee Zee rep/escort will escort you to the nearest Shelter in Place.

Visitor/Vendor Contractor Safety Requirements

Visitors/Vendors/Contractors

We at Dee Zee value our Environment along with your safety and health. We consider our Visitors, Vendors and Contractors as members of the Dee Zee family and to uphold a positive safety, health and environmental culture. To achieve this, we ask that all visitors, vendors and contractors understand and follow all PPE requirements. This does not provide an all-inclusive list of PPE requirements and additional PPE may apply. Please consult your Dee Zee rep/escort or management for any additional questions. High interest items follow:

- No cell phone use while walking through plants, warehousing or production areas
- No ear buds are allowed in production or warehousing areas
- PPE shall be worn in all required areas
- Report any injuries or near misses to your rep/escort
- Stay with your rep/escort during tours
- Remain on pedestrian walkways (if provided) when going to other parts of the plant
- Tornado/Fire/Power Outages Dee Zee rep/escort to provide further instruction
- Ensure all recyclable material is placed in appropriate containers (soda cans, paper and etc....)
- Do not bring in Hazardous Materials without prior approval of Dee Zee Environmental, Health and Safety.

SAFETY GLASSES



All production and warehousing areas at all Dee Zee locations require safety glasses.

Prescription glasses do not provide adequate protection and OTG safety glasses shall be used. Office areas and breakrooms do not require the use of safety glasses. Please inquire with your Dee Zee rep if you need this item.

FOOT PROTECTION



All production and warehousing areas at Dee Zee require one of two types of foot protection. This will vary based on your area you will be visiting, supplying or providing services to.

Foot Protection - Non-Steel Toe



In areas of production and warehousing that DO NOT require steel-toe shoes, requires foot protection of a sturdy, slip-resistant, puncture resistant shoe. Visitors/Vendors may choose to stay on walkways where steel toe shoes would be required to alleviate the need for steel toe shoes.

Foot Protection - Steel Toe



Steel Toe foot protection is mandatory in certain departments throughout various Dee Zee locations. Dee Zee will provide toe caps if you are required to enter these mandated areas. Please inquire with your Dee Zee rep if the area you will be entering requires steel toe. Visitors/Vendors may choose to stay on walkways where steel toe shoes would be required to alleviate the need for steel toe shoes.

*NOTE – Any PPE required by the work outside contractors are performing, shall be the sole responsibility of the contracted company to ensure PPE is provided.
